
## **TRAVELING FOR CONNECTION AND IMPROVEMENT**



For example, say a trucking company obtained a potential driver's Illinois driving record. If that record is littered with speeding offenses or other moving violations, the driver's ability to follow laws comes into question. Similarly, if a past employer indicates that the driver being screened had made false entries in his log books to get around federal hours of service requirements, it demonstrates a willingness to put personal financial gain over public safety.



As our case and other negligent or reckless hiring cases have shown over the last few years, juries will not condone companies that ignore the safety of the public by hiring unqualified and dangerous drivers.
